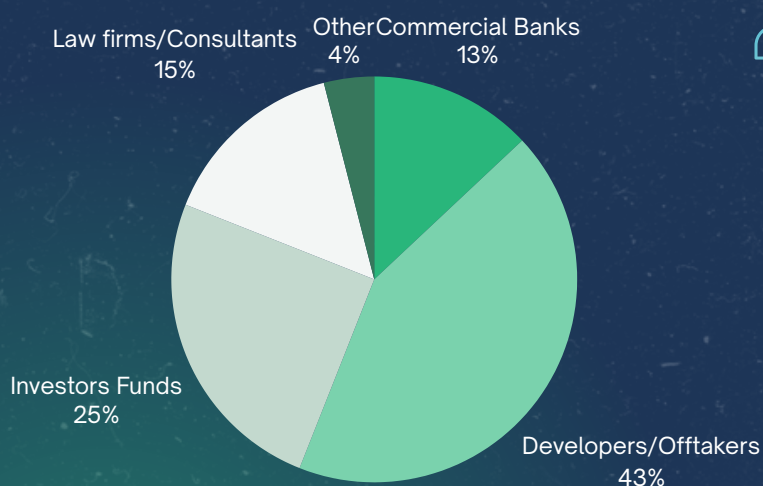

2025 AGENDA TOPICS
