

Europe Energy Transition Awards Submissions FAQs Submission Deadline: 19th May 2025

1. HOW CAN I SUBMIT AN ENTRY FOR THE AWARDS?

Any company or individual actively involved in the European energy transition sector is eligible to submit an entry. This includes developers, investors, financial and legal advisers, lenders, technical consultancies, and technology providers.

2. HOW DO I SUBMIT AN ENTRY FOR THE AWARDS?

Submissions can be made via our online portal. You will need to complete the entry form, providing details of the project, transaction, company, or individual you are nominating, along with supporting evidence.

3. WHAT PROJECTS WILL BE ELIGIBLE?

The committee will consider any European renewable energy and energy transition project or deal to reach financial close between 1 April 2024 and 31 March 2025.

4. IS THERE A FEE FOR SUBMITTING AN ENTRY?

No, submission for the awards is free of charge. However, shortlisted nominees will be required to purchase tickets for the awards ceremony should they wish to attend.

5. CAN I SUBMIT MULTIPLE ENTRIES?

Yes, you can submit entries for multiple categories, provided that each entry meets the specific criteria outlined for that category.

6. WHAT IS THE DEADLINE FOR SUBMISSIONS?

The deadline for submissions will be announced soon. We recommend submitting well in advance to allow time for any additional clarifications if needed.

7. WHAT SUPPORTING MATERIALS SHOULD I INCLUDE IN MY SUBMISSION?

Each entry should include a written explanation of why the nominee deserves to win, along with relevant data, case studies, or supporting documents such as financial close details, technical reports, or market impact analysis.

8. CAN I NOMINATE A COMPANY OR INDIVIDUAL OTHER THAN MY OWN?

Yes, you can nominate a company or individual outside of your organisation, provided you can supply supporting evidence for their achievements.

9. HOW ARE SUBMISSIONS EVALUATED?

Entries will be reviewed by inspiratia's awards committee, composed of internal and external industry experts based on predefined judging criteria.

10. WILL MY SUBMISSION REMAIN CONFIDENTIAL?

Yes, all submissions are treated as confidential. Only high-level details of winning and shortlisted entries will be shared publicly.

11. WHEN WILL THE FINALISTS BE ANNOUNCED?

Shortlisted finalists will be notified via email and announced publicly approximately six weeks before the awards ceremony. Up to five nominees will be shortlisted per category.

1. WHEN AND WHERE IS THE AWARDS CEREMONY TAKING PLACE?

The Energy Transition Awards 2025 ceremony will be celebrated in November in London.

2. HOW CAN I PURCHASE TABLE PACKAGES FOR THE AWARDS CEREMONY?
